Thompson to retire from National Sheriffs' Association (NSA)

"For a decade, Jonathan has been a driving force in helping move the NSA forward, overcoming many hurdles and challenges. Working alongside the NSA Executive Committee leadership and Board of Directors, he has been asked to make some tough decisions, and the Association is undoubtedly better because of it. His experience and relationships inside the Beltway and on Capitol Hill have been instrumental to the NSA's success in advocating for the Office of Sheriff, Sheriffs, and law enforcement interests in Washington, D.C., and across the nation."

The NSA is officially accepting applications for the position of Executive Director. Candidates should have extensive law enforcement experience and/or considerable exposure to the policy, legislative, judicial, and regulatory activities that affect the NSA's membership and its partners.

Applicants must submit a cover letter outlining their vision, the unique skills they bring to the Association and its membership, and salary requirements. The submission deadline will be January 30, 2025, and no calls or in-person inquiries will be engaged.

"Jonathan will remain active with the NSA at the end of his tenure, working on a vital set of projects," added Sheriff Donahue. "At my request, he has agreed to make himself available to assist with the transition of the new Executive Director once that person has been selected."

"This has been an honor of a lifetime," proclaimed Mr. Thompson. "I've had a front-row seat at the most important moments in law enforcement these past 10 years. The success we've encountered isn't the result of one person or Sheriff. Rather, it has been our employees, our member Sheriffs, the Chief-Deputies, Under-Sheriffs, deputies, and partners who have done the lion's share of the work. I will never forget the reason we fight as hard as we do, because every day deputies, corrections officers, and dispatchers pledge to protect everyone in their community, regardless of their social status, gender, race, political views, or personal circumstances. We owe these public servants an enormous debt, and should be 110% committed to helping them succeed."
